论坛简介

联合国 2030 年可持续发展议程旨在通过国际集体行动，全面解决全球社会、经济和环境三个维度的可持续发展问题。过去三年，新冠肺炎疫情给世界各国带来重大损失，并可能将实现 17 个全球发展目标（SDGs）的时间再后推 10 年。而发展中国家的可持续投资年度资金缺口，已高达 4.2 万亿美元。如何加速可持续融资，不让任何人掉队（left no one behind），任务迫在眉睫。

第四次工业革命作为一场范式变革，正从根本上改变生产、消费乃至整个社会。人工智能（AI）作为新工业革命先进数字制造（ADP）领域最核心的技术之一，已成为全球投资热点。AI 正日益成为促进 SDG 实现的有力工具，但其快速发展也带来潜在风险，对部分目标的实现形成挑战，这一趋势值得密切关注。

当前，距实现可持续发展目标所剩时间已不多。步入“行动十年（Decade of Action）”，如何利用 AI 等先进数字技术促进可持续投资，将投资供需双方高效匹配，

使投资更精准地向可持续发展领域聚焦，特别是为广大发展中国家提供更多可持续投资的融资渠道，是现阶段亟待解决的问题。同时，AI 技术自身也需要实现可持续发展。

在此背景下，联合国工业发展组织投资和技术促进网络（UNIDO ITP Network）在 2022 年服贸会上举办的“ESG 与可持续投资国际论坛”基础上，创新提升，拟于今年 9 月 3 日在北京举办 2023 中国国际服务贸易交易会“全球人工智能与可持续投资论坛”，聚焦“IP 4.0 - 人工智能赋能可持续投资”和“ESG 2.0 - 可持续投资中的新变量”两大主题，邀请国际组织及多国代表、中国相关部委和地方政府、国内外数字产业、金融投资和科技创新领域领军企业、媒体智库和院士专家，以及“第四次工业革命产业联盟”成员等利益攸关方，展开深入交流，分享最佳实践，提供解决方案，为推动联合国 2030 年可持续发展目标的实现贡献力量。

Introduction

The UN 2030 Agenda for Sustainable Development aims to address sustainable development issues in the social, economic, and environmental dimensions through international collective actions. Over the past three years, the COVID-19 pandemic has caused significant losses for countries worldwide and may push back the deadline for achieving the 17 Sustainable Development Goals (SDGs) by another 10 years. The annual funding gap for sustainable investment in developing countries has reached \$4.2 trillion. Accelerating sustainable financing to ensure that no one is left behind has become an urgent task.

As a paradigm shift, the Fourth Industrial Revolution is fundamentally changing production, consumption, and society as a whole. Artificial intelligence (AI), as one of the most critical technologies in the Advanced Digital Production (ADP) field of the new industrial revolution, has become a global investment hotspot. AI is increasingly becoming a powerful tool for achieving SDGs, but its rapid development also brings potential risks and challenges to achieving some goals, which deserves close attention.

Currently, there is not much time left to achieve the SDGs. As we enter the "Decade of Action," how to use advanced digital technologies such as AI to promote sustainable investment, efficiently match investment supply and demand, and focus investments more accurately on

sustainable development areas, especially by providing more sustainable financing channels for developing countries, is an urgent issue to be addressed. At the same time, AI technology itself also needs to achieve sustainable development.

Against this background, the United Nations Industrial Development Organization's Investment and Technology Promotion Network (UNIDO ITP Network), building on the "ESG and Sustainable Investment International Forum" held at the 2022 China International Fair for Trade in Services (CIFTIS), will innovate and upgrade to host the "Global Forum on Artificial Intelligence and Sustainable Investment" on September 3, 2023, in Beijing, as part of the 2023 CIFTIS. The forum will focus on two major themes: "IP 4.0 - AI Empowering Sustainable Investment" and "ESG 2.0 - New Variables in Sustainable Investment." It will invite international organizations and representatives from multiple countries, relevant Chinese ministries and local governments, leading companies in digital industries, financial investment and technological innovation fields at home and abroad, media think tanks and academic experts, as well as members of the "Fourth Industrial Revolution Alliance" and other stakeholders to engage in in-depth exchanges, share best practices, provide solutions, and contribute to achieving the UN 2030 Agenda for Sustainable Development.

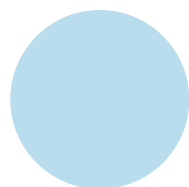
